

On & On Training Camp & Audition 2025 Registration Terms & Conditions and Rules & Regulations

1. General Overview

1.1. The K-Pop Training Camp & Audition (the “Event”) are jointly hosted by Falcon TVET University/Falcon Skills Academy Sdn Bhd & On Music (the “Hosts”).

1.2. The Event is designed to provide participants (the “Participants”) with K-Pop training sessions followed by an audition process. Participants will receive training in dance, vocals, stage presence, and other relevant skills. The audition will assess each Participant’s potential for advancement in the K-Pop industry.

1.3. Participation in the Event is subject to the acceptance of these Terms & Conditions and adherence to the Rules & Regulations outlined herein.

2. Eligibility

2.1. Participants must be between the ages of **15** and **25** on the date of the registration.

2.2. Participants must possess a valid passport or legal identification.

2.3. Participants must not have any existing contractual agreements with any entertainment companies, talent agencies, or management companies.

2.4. Participants under the age of 18 must provide a signed consent form from a parent or legal guardian.

2.5. The Hosts reserves the right to verify the eligibility of all Participants and disqualify any Participant who does not meet the eligibility criteria.

3. Registration Process

3.1. Registration for the Event must be completed through the official Event website or designated registration portal.

3.2. Participants are required to submit the following documents during registration:

- A completed registration form.
- A copy of a valid passport or legal identification.
- A recent photograph (headshot).
- A performance video or audio clip.
- Signed consent forms (for minors).

3.3. Registration fees are RM6,600 and must be fully paid before the date of the training camp. The registration fee is non-refundable. Rebate of 5% for early bird promotion, and we provide instalment scheme to the participants. For further information, please visit our website at www.onandon.my.

3.4. Registrations are accepted on a first-come, first-served basis, subject to availability.

3.5. The Hosts reserves the right to close registration once capacity is reached or extend the registration period at its discretion.

4. Cancellation and Refund Policy

4.1. Participants may cancel their registration by providing written notice to the Hosts at least 30 days before the Event start date.

4.2. No refunds will be issued for cancellations made less than 14 days before the Event start date.

4.3. In the event that the Hosts cancel the Event, Participants will receive a full refund of the registration fee.

4.4. Refund will be subjected to the Hosts discretions.

4.5. The Hosts are not responsible for any other expenses incurred by the Participants in connection with the Event, including travel and accommodation costs.

5. Training Camp Rules & Regulations

5.1. Attendance & Punctuality

- Participants must attend all scheduled training sessions.
- Participants are expected to arrive on time for all sessions. Late arrivals may result in penalties or disqualification.

5.2. Conduct & Behavior

- Participants must behave respectfully towards instructors, staff, and fellow participants at all times.
- Any form of harassment, bullying, or discrimination will not be tolerated and may result in immediate disqualification.
- Participants must adhere to the dress code as specified by the Hosts.

5.3. Health & Safety

- Participants must inform the Hosts of any medical conditions or special needs prior to the start of the Event.
- The Hosts reserves the right to remove any Participant from the Event if their health or safety is at risk.
- Participants are responsible for their own health and safety during the Event.

5.4. Prohibited Activities

- The use of alcohol, illegal substances, or smoking during the Event is strictly prohibited.
- Participants are not allowed to bring weapons or dangerous items to the Event.

6. Audition Process

- 6.1. The audition will be conducted by a panel of judges selected by the Hosts.
- 6.2. Participants will be evaluated based on their performance in dance, vocals, stage presence, and overall potential.
- 6.3. The decision of the judges is final and cannot be contested.
- 6.4. Participants may be asked to perform additional tasks or attend callbacks as part of the audition process.
- 6.5. Selected Participants will be offered further training or development opportunities by the participating Korean entertainment companies with provided training allowances, accommodation, meals and professional trainers for the further training in South Korea.
- 6.6. The Hosts will sponsor the flight ticket to South Korea for the selected participants.

7. Use of Likeness & Media

- 7.1. By participating in the Event, Participants grant the Hosts the right to use their name, image, likeness, and performance in any promotional materials, media coverage, or marketing campaigns related to the Event.
- 7.2. Participants agree that any recordings, photographs, or other media captured during the Event are the property of the Hosts and may be used without additional consent or compensation.

8. Confidentiality & Non-Disclosure

- 8.1. Participants may receive confidential information during the Event. Participants agree not to disclose or use this information for any purpose other than participating in the Event.
- 8.2. Any breach of confidentiality may result in immediate disqualification and legal action by the Hosts.

9. Liability & Indemnity

- 9.1. The Hosts are not liable for any injuries, accidents, or losses that may occur during the Event.
- 9.2. Participants agree to indemnify and hold the Hosts harmless from any claims, damages, or liabilities arising from their participation in the Event.

10. Governing Law

- 10.1. These Terms & Conditions and Rules & Regulations are governed by the laws of Malaysia.
- 10.2. Any disputes arising from participation in the Event will be resolved through arbitration or in the courts of Malaysia.

11. Amendments

11.1. The Hosts reserves the right to amend these Terms & Conditions and Rules & Regulations at any time. Participants will be notified of any changes via email or the official Event website.

12. Acceptance
